## TUITION INVESTMENT SCHEDULE 2017-2018

**APPLICATION FEE:** \$50.00 per application, non refundable.

**REGISTRATION FEE:** \$495.00 per family, refundable only if no space is available or admission is denied.

**TESTING FEE:** \$50.00 testing fee for new applicants.

**TECHNOLOGY FEE:** \$100.00 per student. (Kindergarten-12th Grade)

**ACTIVITY FEE FOR SPORTS:** \$150.00 per Varsity/Junior Varsity sport each school year. For students participating in two or more Varsity/Junior Varsity sports the athletic fee is \$300.00. \$100.00 per Middle School sport. For students participating in two or more Middle School sports, the fee is \$200.00.

Maximum tuition cap PER FAMILY is the sum of the three highest paying students. (PK4-12th Grade only)

### TUITION PAYMENT CHOICES:

**ANNUAL:** A 3% discount is given if tuition is paid in full by June 1, 2017.

**SEMI-ANNUAL:** Payment is divided into two equal payments due by June 1 and December 1, 2017.

**MONTHLY:** 12 equal monthly payments starting in June 2017 and ending in May 2018 or 10 equal monthly payments, first payment due on June 2017 skip July and August, and resume payments in September 2017 through May 2018. Monthly plan includes a \$4 per month, per student service charge. All monthly payments payable through FACTS Tuition Management.

**DOWN PAYMENT:** Down payment amount due June 1, 2017. The remaining balance will be in 12 or 10 equal payments.

**CONTRIBUTIONS:** Tuition does not pay the total cost to operate Lake Worth Christian School; therefore, the Board of Directors asks that each family pray for the school and consider a gift or pledge for the school year. Lake Worth Christian School is a nonprofit corporation and contributions are tax deductible.

**TUITION MANAGEMENT:** LWCS uses the FACTS Tuition Management Program to handle all installment payment plans and fees. These fees will be handled with your tuition payments as part of the FACTS installment payment program. **WITHDRAWAL:** If the student withdraws or is asked to leave, the remaining balance of tuition for such semester will be due and payable as of the date of withdrawal. There will be a \$200 withdrawal fee.

**EXTENDED DAY CARE:** Available Pre-K – 8th grade Aftercare from 3:00 p.m. – 5:30 p.m.  
Rate: \$3.75 per hour, \$2.00 per minute after 5:30 p.m.

**FINANCIAL AID:** LWCS's tuition reflects a desire to maintain quality programs at an affordable price. Our Board of Directors is willing to work with Christian families to try to make tuition affordable to all who desire a Christian education for their child. Financial Aid applications are based on need, and available online at [www.LWCS.org](http://www.LWCS.org) under Admissions. (Need based financial aid is not available for the 3 year old program)
